****Awardees may receive a financial award to use to the benefit of their business or project and/or technical assistance that could include free logo design, legal services, accounting and financial services, and other business support. All applications may receive some technical assistance depending on need and availability.***

- Presentation order will be randomly selected in advance.
- Each Presenter(s) will be allotted 5 minutes to present. A timekeeper will be on hand to help monitor time and give a signal one minute before the ending time.
- Time will be given at the end of each presentation for short 5 minute Q and A session from the judges.
- Presenters may have visual aids to enhance the performance and to set up a display for event attendees to view. Visuals may include photos, samples, a TV or laptop with a running slide-show, brochures, business cards, etc.
- Presenters must inform ROBERT BURNS (edirector@tuckerfoundation.net) AT LEAST 24 HOURS IN ADVANCE of any necessary audio/visual software/hardware needs. The presentation is of your design, style, and technique, as long as it is within the time allotment.
- There will be **very brief** intervals between presentations to allow for set up.
- At the end of **all** the presentations, all votes MUST be placed in the designated ballot box to be collected and tabulated
 - Attendees and Presenters can only vote for one choice
 - Judges' votes count as 10 points each.
- The winner will be issued the monetary award certificate at the conclusion of the tallied votes. The money will be distributed via an invoice for business requirements.
- Photos and information will be gathered to feature and share online by the sponsors of the event at the conclusion of the event
- Please be present at Auditorium at the Tucker County High School on June 15th and Presentations will begin at 6:00 PM **sharp**
- Judges will keep the applications confidential but note that anything shown during the presentation to judges will be to the general public.
